I. INTRODUCTION

Bill Murray, Chair, called the meeting to order at 6:30 pm, welcomed participants and reviewed the plan for the walking tour and discussion of the Coastal Trail.

II. PUBLIC COMMENT

III. COASTAL TRAIL DISCUSSION

The following items were discussed during the walk north to Kelly Avenue and return to Poplar Beach:

 Speed limits
 Speed limits of 10 MPH (5 MPH at crossings) should be painted on the pavement at crossings and at mid-section. b. Signage

Signs shall be mounted low.

c. Crosswalks

There should be a pedestrian crosswalk painted at Kelly Avenue

d. Enforcement

Sheriff's office representative should be present at a future BPAC meeting to discuss enforcement

e. Mileage/wayfinding

Mileage signs and directions to restaurants and points of interest should be erected.

f. Pavement markings

Intermittent striping for median shall be marked.

g. Volunteers

Volunteer Trail Patrol should be explored

h. Right of way

Hierarchy on the right way for pedestrian, horses, bikes

i. Near future relocation of Trail inland

Brittney Cozzolino of City's Planning Department explained the future plans for the relocation of the trail to about 100 feet inland. The future trail is proposed to have decomposed granite surface.
